Rosco congratulated newly elected officers and thanked John Kellett for the time he served as Chairman Also thanked Tim Emery for taking reigns and his many years on both boards. Told Board regarding lot on Beech Daly and Dartmouth had trees removed and that they were small trees but left mess underneath. Joe Karoub got in touch with Olsen Cement and Rosco authorized them to grade the area. Regarding Van Born project, City did not extend moratorium regarding used car lots. Council Chair trying to set up joint meeting with Taylor; Rosco explainted to her who was in charge in Taylor. Willis asked about building on Gulley and Van Born and what is it turning into? Rosco answered that they had wanted to put in a used car lot but had come across some information that the owner might be putting in a frozen custard. However, since no moratorium now may go back to a used car lot. Constan stated he had heard it was a new location for a Custard Hut.

With regard to new budget, Rosco said the Police Department sign went out for bids and had re-bid due to new information and suggestions they became aware of. Will bring information back to board as soon as available.

Wojciechowski asked about status of Mayor of Taylor; Rosco said Taylor is on track and ready to go on Van Born project. Constan said Mayor is indicted, but Taylor is still committed to Van Born project. Korte asked about funds for engineers; Rosco said never heard back from them

Chairman Emery then declared the meeting adjourned at 6:54 PM.
